Regulation of veterinary products, dairy now under DA from FDA

MANILA – The Department of Agriculture (DA) on Friday announced the transfer of some regulatory functions to the Bureau of Animal Industry (BAI) and the National Dairy Authority (NDA) from the Food and Drugs Administration (FDA).

This came after the DA and FDA issued a joint advisory on the jurisdiction shifts following the enactment of Republic Act 12308 or the Animal Industry Development and Competitiveness Act.

Under the transfer, jurisdiction over veterinary drugs, products and biologics and other animal health products and devices will move from the FDA to the BAI.

The NDA will assume "full regulatory authority" over the dairy industry, including testing and accreditation of local dairy products and overseeing production through post-market distribution.

The FDA will continue evaluating applications filed before Oct. 28, with pending cases up to April 25, 2026, to be handed over to the BAI or NDA for final decisions. All FDA-issued permits remain valid until their expiration dates. Applications submitted after Oct. 28 will now be processed by BAI and NDA.

Current fee schedules will remain in effect unless revised by DA agencies following public consultation. (PNA)

MANILA – First Lady Liza Araneta-Marcos on Saturday commended the Philippine Coast Guard Auxiliary (PCGA) for its unwavering commitment to safeguarding the country.

In an Instagram post, Araneta-Marcos shared photos of her attendance at the PCGA Executive Squadron Assembly 2025 held at Admiral Suites Residential in Manila.

Araneta-Marcos said she was honored to stand with volunteers whose courage, discipline, and compassion continue to strengthen the organization's mission.

"Thank you for the sacrifices you make to keep our country safe. Your service means more than words can ever express," she said.

Araneta-Marcos, who also serves as a member of the Auxiliary, said the PCGA has allowed her to work with individuals who demonstrate steadfast dedication to public service.

She expressed particular pride in serving alongside the Executive Squadron, describing its members as leaders who "steer the mission with heart and strengthen the impact we make together."

"Being part of the PCGA has allowed me to meet comrades whose courage, discipline, and compassion never waver," Araneta-Marcos said. "Proud to stand with all of you in service to our nation."

PBBM VOWS...

President Marcos made the commitment as he visited the NING*NING 6.55-Megawatt Peak Solar Rooftop Power Facility at Pasinaya Homes in Naic, Cavite — hailed as the world's first grid-connected, utility-scale solar rooftop project within a socialized housing community.

The NING*NING Project equips 1,986 homes with rooftop solar panels, allowing them to collectively generate clean power.

The President stressed that aside from providing solar power, the project also generates revenue, which will help sustain community services such as roof repairs, street lighting, waste management, shared solar facilities, and resident training programs.

"In other words, the energy that we produced here will power a better life for the people who live in this community, but even beyond this community," President Marcos said.

"Because although there are advantages, there are benefits to those living in this community, there is also the benefit to the grid because you are providing additional power, which we all know is something that we need."

The President praised the project for utilizing existing rooftops, noting that no farmland is used, no livelihoods are disrupted, and no land is wasted.

President Marcos said the project is expected to reduce over 6,233 metric tons of carbon dioxide emissions per year, like removing nearly 1,000 vehicles from the road.

The President said the project's innovative work has already earned international recognition, winning Gold for ESG Integration Excellence and Silver for Sustainable Renewable Energy Initiative of the Year at the Asian Power Awards 2025.

President Marcos then congratulated Solaris Inc., the solar energy arm of Joy-Nostalg Group, and its development arm, Raemulan Lands Inc., as well as their other partners, for showcasing Filipino innovation on the global stage.

"I believe that this community in Naic is just the beginning... Imagine what we can do if we replicate this sort of effort in neighboring communities and, later on, the rest of the country," the President said.

President stressed that closer collaboration between the government, private sector, and local communities is crucial for expanding renewable energy initiatives across the country, especially in the face of climate change challenges.

"Kailangan natin ng tulong ng bawat komunidad, bawat pamilya, bawat Pilipino,"

the President said.

On the part of the government, the President said the administration will continue improving processes to promote, support, and accelerate more innovative renewable energy projects.

"Indeed, our collaboration demonstrates what can be achieved when the government, the private sector, and communities work together to create sustainable solutions," President Marcos said.

SSS clarifies reports on red tape complaints; All cases addressed

In light of recent news reports citing the list of most complained-about government agencies based on January to August 2025 data presented by the Anti-Red Tape Authority (ARTA) to the Senate during budget deliberations, the Social Security System (SSS) wishes to assure the public that its management takes these matters seriously and is committed to continuous improvement in service delivery.

"SSS is currently coordinating with the Anti-Red Tape Authority to validate the reported data involving 244 complaints. From our own monitoring of ARTA referrals, all complaints received during the period covered were addressed and resolved within ARTA standards as our resolution rate is at 99.3%. For the period covered by ARTA presentation to the Senate, SSS tracked a total of about 474,000 emails working diligently until they are all resolved within ARTA standards," SSS President and CEO Robert Joseph Montes De Claro said.

"Most complaints are about our service delivery, followed by matters concerning our loan programs, and then about contributions matters. Service delivery complaints were mainly about queuing at the branches and repeat visits to SSS branch for a benefit claim. Loan programs complaints were about salary loan and calamity loan programs – both were

enhanced this year featuring lower interest rates – mainly on difficulty as regards calamity loan applications and challenges on loan eligibility requirements and procedures. Contributions complaints were mainly about non-remittance by employers and long wait time for manual verification," De Claro explained.

As far back as June 2021, the SSS created a Committee on Anti Red Tape (CART) with effective receiving of complaints and feedback as a major function and responsibility. Such complaints and feedback are received by SSS via hotline, corporate email, postal mail, referrals from various government entities including ARTA, and through SSS Branches. We also monitor news reports and social media for SSS-related matters and issue Press Releases or Statements to keep our stakeholders informed.

The Department of Tourism (DOT), in an advisory on Saturday, said concerned government agencies continue to monitor the situation.

It asked tourists to stay updated through the official websites of their airlines and avoid relying on unverified social media posts to prevent misinformation.

"Given the evolving situation, travelers are advised to allot sufficient lead time by arriving at least four hours before international flights or three hours before domestic departures, unless advised otherwise by their airlines," it said. BOC sets 2nd auction for Discaya luxury vehicles on Dec. 5

MANILA – All local and international travelers in the Philippines are advised to plan accordingly amid the flight disruptions caused by an urgent Airbus software issue that prompted some airlines worldwide to cancel flights.

The Department of Tourism (DOT), in an advisory on Saturday, said concerned government agencies continue to monitor the situation.

It asked tourists to stay updated through the official websites of their airlines and avoid relying on unverified social media posts to prevent misinformation.

"Given the evolving situation, travelers are advised to allot sufficient lead time by arriving at least four hours before international flights or three hours before domestic departures, unless advised otherwise by their airlines," it said. Philippines Airlines, Cebu Pacific and AirAsia Philippines canceled some domestic flights that will use Airbus 320/321 units.

Tourists whose flights are confirmed canceled, meanwhile, were told not to proceed to the airport unless instructed to do so.

Travelers who may require assistance may reach the DOT Tourist Assistance Call Center through its hotline 151-TOUR (151-8687), 0954-253-3215, or email at touristassistance@tourism.gov.ph. Airbus ordered immediate repairs to 6,000 of its widely used A320 jets, including reverting to earlier software, after discovering a flaw linked to solar flares.

The Guardian said Airbus acknowledged a recent incident involving an A320-family aircraft had revealed that intense solar radiation may corrupt data critical to the functioning of flight controls.

Reuters reported there are around 11,300 A320-family jets in operation, including 6,440 of the core A320 model, which first flew in 1987.

Four of the world's 10 biggest A320-family operators are major United States airlines: American Airlines, Delta Air Lines, JetBlue and United Airlines.

Chinese, European and Indian carriers are also among the jet's biggest customers, according to Reuters. (PNA)

DHSUD: Over 1K beneficiaries to get COEs as early Christmas gift

MANILA – The administration of President Ferdinand R. Marcos Jr., through the Department of Human Settlements and Urban Development (DHSUD), is set to end the decades-long wait for more than 1,000 families to secure their Certificates of Entitlement (COEs) for land covered by presidential proclamations.

This, as DHSUD scheduled this month the awarding of COEs which marks another major step in strengthening land tenure security for underprivileged Filipinos under the flagship Expanded Pam-bansang Pabahay Para sa Pilipino (4PH) Program.

The awarding, covering residential lands in Los Baños, Laguna; Lucena City, Quezon; and Jaro, Iloilo City, will end the decades-long wait of the pro-

spective beneficiaries.

These sites were declared suitable for socialized housing through Presidential Proclamation Nos. 550, 436 and 1538, respectively.

DHSUD Secretary Jose Ramon Aliling underscored that the distribution of COEs advances the national government's commitment to utilize idle public lands for public housing.

"Ang awarding po ay maagang pamasko na ha-

tid ng administrasyon ni Pangulong Marcos Jr. na

patuloy na nagnanais mabigyan ng kapanatagan ang ating mga kababayan matagal nang nagh-

intay ng seguridad sa kanilang lupang tinitirhan

(The awarding is an early Christmas gift brought by the administration of President Ferdinand R. Marcos Jr., who continues to seek to provide security to our countrymen who have long been waiting for security in their land of residence)," Aliling said in a news release on Sunday.

In Los Baños, Laguna, a total of 764 beneficiaries from Barangays Lalakay, Bambang and Timugan have been cleared following the completion of the Local Inter-Agency Committee (LIAC) validation.

The COEs are set to be awarded in three batches beginning December 2025 through early 2026.

In Jaro, Iloilo, preparations are now ongoing for the awarding of COEs to 216 qualified families during the Yuletide Season.

In Lucena City, the LIAC has already completed the validation process for 185 beneficiaries, and the awarding is scheduled in January 2026.

Aliling emphasized that this timeline allows final verification, beneficiary confirmation and coordination with local authorities to ensure accuracy and transparency.

"Hindi lang bahay ang pinag-uusapan dito. Kapag may pinanghahawakan sila na nagsasabing kanila ang lupang tinitirhan nila, mas may kapanagan ang ating mga kababayan (It's not just about houses. When they hold onto something that says the land they live on is theirs, our countrymen will have more security)," he said.

"Ito ang layunin ng ating Pangulong Marcos Jr. sa ilalim ng Expanded 4PH—ang bigyan ng mas may dignidad na pamumuhay ang bawat pamilyang Pilipino (This is the goal of our President Marcos Jr. under Expanded 4PH—to provide a more dignified life for every Filipino family)."

The DHSUD assured the public that it will continue working closely with concerned local governments and national agencies to guarantee the smooth distribution of COEs under Presidential Proclamations in the months ahead.

"As instructed by the President, we will do what we can to expedite the awarding of COEs in accordance with existing policies. We want to give our fellow Filipinos the land tenure security they have long been waiting for," Aliling said. (PR)

Air Force gets 5 more Black Hawk helicopters

MANILA – The Philippine Air Force (PAF)'s humanitarian assistance and disaster response (HADR) capabilities received a much-needed boost as five more S-70i Black Hawk helicopters were commissioned into its service Friday.

In a statement, PAF spokesperson Col. Ma. Christina Basco said the acceptance, turnover and blessing ceremonies for the aircraft took place at the 250th Presidential Airlift Wing at Villamor Air Base in Pasay City.

Department of Budget Management Secretary Amenah Pangandaman, PAF chief Lt. Gen. Arthur Cordura, and Department of National Defense (DND) Undersecretary for Acquisition and Resource Management Salvador Melchor Mison Jr. attended the ceremony.

The helicopters comprise the fourth batch under the 32-unit S-70i acquisition from Poland's PZL Mielec, procured through the Armed Forces of the Philippines (AFP) modernization program.

The latest batch arrived in the Philippines on Oct. 20, following previous deliveries of five units each on June 10 and Dec. 9, 2024; and July 15.

Each helicopter underwent technical inspection and acceptance process on Oct. 22 to 26, conducted jointly by the DND, AFP and PAF, to ensure compliance with operational standards.

The aircraft will be operated and maintained by the 205th Tactical Helicopter Wing under the Air Mobility Command.

"With this latest addition, the PAF continues to strengthen its air mobility capability and fulfill its mandate to protect the nation and serve the Filipino people, in times of both humanitarian crisis and conflict," Basco said. (PNA)
